4.1. Description of first aid measures

First-aid measures general : Check the vital functions. Unconscious: maintain adequate airway and respiration. Respiratory arrest: artificial respiration or oxygen.  First-aid measures after skin contact : Wash immediately with lots of water (15 minutes)/shower. Remove clothing before washing. Remove affected clothing and wash all exposed skin area with mild soap and water, followed by warm water rinse.
